
SAMPLE VOLUME BY TYPE: 2696 SAMPLES TESTED

TESTING SUMMARY: 70.0% UNEXPECTED RESULTS




Of the 2696 samples tested, 1888 revealed some type of unexpected result.

An unexpected result is defined as illicit substances detected, drugs not reported as prescribed detected, and/or drugs reported as prescribed not detected.





DISTRIBUTION OF UNEXPECTED RESULTS



Majority of the unexpected results observed were due to Unexpected Drugs Detected.

UNEXPECTED POSITIVE RESULT

79.8%

1707 of the unexpected results observed were samples **positive for drugs not reported** as prescribed⁻.

*includes alcohol and nicotine.

UNEXPECTED NEGATIVE RESULT

0.0%

0 of the unexpected results observed were samples **negative for drugs reported** as prescribed.

UNEXPECTED ILLICIT DRUGS

20.2%

733 of the unexpected results observed were samples **positive for illicit substances**.


- **1636 samples** resulted in a single unexpected result.
- **252 samples** revealed a combination of unexpected results.
- **0 samples** revealed prescribed medications detected in addition to unexpected result(s).





UNEXPECTED DRUGS DETECTED

- 1707 samples tested positive for drugs not specified by you.
- 0 of these samples were positive for prescribed drugs as well as non-disclosed drugs; this combination could mean **higher risk for undesirable outcomes**.




Top Drugs NOT Reported as Prescribed, but Tested POSITIVE

- 1. Oxycodone
- 2. Morphine
- 3. Hydrocodone
- 4. Amphetamine
- 5. Buprenorphine



ILLICIT DRUGS DETECTED

- Illicit drugs were detected in 433 samples.
- 252 of these samples also tested positive for therapeutic drugs.


TESTING FREQUENCY: 1.4 TESTS PER PATIENT, ON AVERAGE

Most patients were tested once during the time period.

PATIENTS WITH 2+ TESTS: 82.3% CONSECUTIVELY UNEXPECTED



Analysis of patients with multiple drug tests* in the past 6 months revealed 289 patients with consecutively unexpected drug tests.

*Analysis of 2 most recent prior toxicology results

Almost all the CMS's Medicare Administrative Contractor's provide that **documentation** in a patient's medical record set forth the **clinician's rationale** for definitive testing and the **medical necessity** for every ordered test on an individual patient basis.


